## TERMS OF AGREEMENT

### PAYMENTS & REFUNDS

I (parent/guardian) on behalf of myself and my spouse (if said spouse is also a parent/guardian of the child/ward) have read, understand and agree to LFFE's Payments & Refunds Policy as follows:

A deposit of \$500 was paid with the application. Full payment is due on May 1 st. For applications received after May 1 st, full payment is due within 30 days of receipt of our enrollment forms and invoice. Please note:

- o If your child's program choices are not available, your deposit will be returned in full.
- o If, upon our review of your child's Enrollment Forms, the offer of a spot is withdrawn by LFFE, a full refund of all payments to LFFE will be made.
- o If, at any point in the admissions process we determine that you have provided incomplete, misleading or false statements we will withdraw the offer of admission and no refund of any payments to LFFE will be made.
- o If you withdraw your child before May 1st (notice of the withdrawal must be made in writing), \$250 of the deposit is refundable.
- o If you withdraw your child after May 1st, there are no refunds for any reason (including, but not limited to: voluntary withdrawal, illness or injury, summer school, or any other reason).
- o If your child leaves a program after it starts, there are no refunds for any reason whatsoever including, but not limited to: voluntary withdrawal, illness or injury, or any other reason. Any costs incurred by LFFE related to an early departure are the sole responsibility of the parents.
- o If your child is dismissed by LFFE during his or her program (for any reason whatsoever, including, but not limited to: discipline, behavior, lack of fitness or motivation, etc. there are no refunds. Any costs incurred by LFFE related to an early departure are the sole responsibility of the parents.

### COMMUNICATIONS, CELL PHONES, PERSONAL ELECTRONICS & PERSONAL PROPERTY
